

THE "GROOVE WITH NOKIA" SWEEPSTAKES RULES AND REGULATIONS

1. NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES: The "Groove with NOKIA" Sweepstakes (the "Sweepstakes") is sponsored by AEG Live LLC, having its principal place of business at 5750 Wilshire Blvd Suite 501 Los Angeles, CA 90036-3638. The Sweepstakes entry period begins on 04/25/08 9:00 a.m (Pacific Time) and ends on 5/26/08 at 11:59 p.m. (Pacific Time) (such period, the "Entry Period").

2. HOW TO ENTER:

(a) Online/SMS Method of Entry: To enter the Sweepstakes online, visit the Sweepstakes at <http://www.nokiathatrelalive.com> (the "Sweepstakes Site") during the Entry Period. All of the Sweepstakes information will be posted at the Sweepstakes Site throughout the Sweepstakes. Using your mobile device text "NTLAPHONE" to 66057. A random drawing for one potential winner will take place on or about May 30, 2008. Participants may enter only once during the Entry Period. Limit of one entry per person and per household, regardless of method of entry. Duplicate entries from the same cell phone number/email address/person/household will be automatically eliminated without notice to the entrant. Where a dispute arises about who submitted an online entry, the entry will be deemed submitted by the holder of the e-mail account. SMS entries must be received by 11:59 PM Central Time, May 26, 2008 according to the Sweepstakes Providers' clock. Odds of winning depend on the number of eligible entries received and are equal regardless of method of entry. Any SMS messages received after 11:59 PM. (Pacific Time) on May 26, 2008 will not be eligible to be included in the drawing and shall be disregarded. No entries will be acknowledged or returned.
